The term of this Club Membership Agreement (this "Agreement") shall commence on the date this Agreement is executed and payment of the required ten dollar (\$10) membership fee is received by the Club. In the event of any dispute with the Club, Member agrees that Club's sole liability shall be the return of the \$10 membership fee to Member. This Agreement will terminate February 28, 2014.
